## 1. APPROVAL OF THE AGENDA

# c. Summer Coaching Fees

Resolved: Head coach fee to be increased by 100% for July and August.

# d. Fall Session

Discussed maintaining the Spring fee amount, but to let parents know that fees that are additional (such as facility fees) will be the responsibility of the parent.
