COLLECTION OF PERSONAL INFORMATION

ALTIUS NORDIC SKI CLUB ("ANSC") collects, uses and discloses Athlete Information to provide our athletes with our services. More specifically, the ANSC collects, uses and discloses your personal information for the following purposes: (i) to assess whether the Athlete meets the qualifications for membership and for competition, (ii) to compile a list of all Athletes for purposes of communicating to them and their parents about Organization activities, meetings, competitions, competition criteria, celebrations and events hosted by the Organization or affiliated organizations in the ski jumping and nordic combined communities in the Province and internationally and for fundraising purposes; (iii) to maintain records for each Athlete for purposes of developing individual training plans; (iv) to respond to an emergency medical situation; and (v) for such other purposes as agreed between the Board of the ANSC and the Athlete and parent, from time to time.

ANSC will collect, use and disclose only that personal information necessary for the purposes that have been identified. ANSC may disclose your personal information amongst itself for the purposes listed herein. To the extent that ANSC is required to share your personal information with any of its affiliated organizations, including Ski Jumping Canada, Nordic Combined Ski Canada, and Alberta Ski Jumping and Nordic Combined (collectively, the "Supporting Organizations"), such disclosure shall be done in accordance with the privacy policy of ANSC which originally collected your personal information.

BY SUBMITTING PERSONAL INFORMATION TO ANSC OR ANY OF ITS SERVICE PROVIDERS AND AGENTS, YOU AGREE THAT ANSC AND ANY OF ITS SERVICE PROVIDERS AND AGENTS MAY COLLECT, USE AND DISCLOSE SUCH PERSONAL INFORMATION AS PERMITTED OR REQUIRED BY PRIVACY LAWS. Subject to legal and contractual requirements, you may refuse or withdraw your consent to certain of the identified purposes at any time by contacting the ANSC's Privacy Officer as listed on the ANSC's website.
